Grand Valley Artists invite you to submit your application to the 45th Annual Reeds Lake Art Festival, located this year on Lake Side Drive and Wealthy Street in East Grand Rapids, Michigan. All artists will be juried by digital images. We expect to have the jury selections completed by March 15th and notification soon thereafter. We look forward to hearing from you soon!

The Booth Fee is \$130.00 for non-members of GVA and \$100.00 for members. GVA members must have their dues paid by February 1, 2010 to be eligible. Once an applicant is accepted by our jury, the booth fee is non-refundable.

A non-refundable Jury Fee of \$15.00 should be sent along with the Booth Fee as a separate check. All checks are to be made payable to **Grand Valley Artists**.

Booth spaces are 12' Wide x 10' Deep. If you are a returning exhibitor and desire a specific location, note that on your application, but be aware that due to changes beyond our control, we may not be able to accommodate your request.

Some double booth spaces will be available. Please indicate below, but **do not** send the fee for more than one booth.

Only original artwork done by the accepted artist may be displayed in the booth. Prints and reproductions are to be displayed in flip bins only.

No stake are allowed. Only weights are allowed to secure booths.

Please enclose a self-addressed, stamped envelope for return of information and jury notification. Make sure there is sufficient postage for the return of CD or photos. We will return all incomplete applications using your envelope. Entries without envelopes or sufficient postage will not be notified.

Application, booth fee, jury fee, self-addressed/stamped envelope, 3 JPG images of artwork (on CD) and 1 image or photo of your booth setup must be received by **March 1st** to be accepted. The images should be 1920 pixels in the longest dimension. Photos should be 4x6 prints.
